## 中国政法大学国际教育学院




### 2015年春季学期小语种班再次火热开班!

### 新开粤语班异常火爆

2014年底开设的小语种班在法大校园掀起外语学习热潮,小老师们均为来自法大的外国留学生。鉴于留学生中还有相当一部分是港澳台学生,国际教育学院因此进行了一个调查,看是否有可能开设粤语班,结果发现有很强学习粤语的需求。为此,决定 2015 年的学期开设粤语班。

### 巴西秘鲁国际教育展

2015年3月,中国政法大学国际教育学院 随北京市教委赴巴西、秘鲁参加了国际教育展 及北京教育说明会。本次外事公务主题鲜明, 主要是在巴西圣保罗参加了"国际教育展"和 在秘鲁利马举行北京教育说明会。活动形式多 样,除了国际教育展和教育说明会,还拜访了 秘鲁国家议会教育委员会、走访了圣保罗、里 约热内卢、利马三个城市的多所大学。在本次 的国际教育展及北京教育说明会上, 很多学生 对来中国留学有很大的兴趣, 中国政法大学受 到了学习法律的学生、律师、公务员的关注, 他们积极地进行咨询,了解法大的课程、住宿 等相关情况,在此期间我校发放了400份宣传 材料,并记录了对来中国政法大学学习感兴趣 的咨询人员的联系方式,学校对外招生政策和 教育教学成绩都有很好的境外宣传效果。期 间,还与秘鲁圣马丁大学草签了合作的意向 书。还同一些学校达成了互派法律学习短期班 的初步意向。

### Law Courses for 2015 Spring semester

For the spring semester of 2015, ten law courses are being taught in English. Criminal Justice inChina, Chinese Labor Law, Chinese Legal System, Foreign Investment Law in China, Company Law, Chinese Securities Law, Private International Law, Introduction to Chinese Legal system, EnvironmentalLaw and Intellectual Property Law have been offered by the School of International Studies to international students, especially LL.M. and exchange students. Through these courses, international students will gain both a general overview and specific knowledge of Chinese law, as well as international law. As many exchange students were interested in business law, CUPL has offered a course on Chinese Securities Law. The Chinese securities market is well developed in terms of products and methods of raising capital. The leading banks are all listed companies and securitization has connected many financial sectors. It follows that the securities law is a key component of financial laws and regulations.





The course aims to introduce the regulatory regime of Chinese securities law, and how the laws and regulations are applied by Chinese courts and regulators. For this purpose, there will be a discussion of the basic concepts of securities law and the unique Chinese legal and cultural backgrounds. Laws and regulations, judicial interpretations and court cases will be discussed. Where appropriate, a comparative legal approach will be used to illustrate important points.

Meanwhile, the course of Foreign Investment Law in China will provide students with a general knowledge of foreign investment law in China, including its concepts, characteristics, historical development and classic theories. It will also expand on the societal and political background to developments in this area of law. At the end of the course, students will be able to understand the main applicable foreign investment laws issued by different levels of the Chinese government and conduct independent research and critical thinking on foreign investment law. Students will also develop the necessary skills to prepare legal opinions and provide advice with respect to issues of foreign investment law.

In addition to the above courses, the Faculty of International Law has provided International law courses such as International Private Law, International Public Law, Environmental Law, Intellectual Property Law, Human Rights Law, Legal Research and Writing, Arbitration Law and Air and Space Law.

The Legal Research and Writing course will teach students more specific skills. The professor will give an overview of different sources of law to encourage students to make use of these sources both in Chinese and international law. Students will also learn how to read and interpret court decisions and utilize the internet as a source of law. Finally, the course will focus on teaching students how to write a legal essay.

During this semester, six optional courses were offered to students, namely Chinese Society and Culture, Buddhism in China, Chinese Drama Stories, Chinese Tea Culture, Multicultural Psychology and China's Contemporary Politics and Society.



### 本学期的中文课程

中国政法大学国际教育学院开设不同类型和层次的汉语进修课程,为具有不同汉语水平和多样化学习兴趣的外国留学生以及在华外籍人士提供优质的教学服务。我院在籍语言生共有83人,生源国有意大利、德国、俄罗斯、法国、菲律宾、巴基斯坦、韩国、几内亚、加纳等28个国家。

根据学生汉语水平分为入门班,基础班,初级班和中级班,学生可根据自己的汉语水平进行选择。入门班主要针对零基础的学生们,从拼音比划开始扎实的学习中文。基础班和初级班主要针对有一些汉语基础的留学生们,在专业的对外汉语老师的辅导下,尽快提高中文的听说读写能力。中级班主要针对中文程度较好,有意向用中文学习其专业的留学生们。

本学期开设汉语听力, 汉语口语, 汉语综合,汉语语法,中国文化,法律汉语,中国太极文化,中国书法等课程。

### HSK 考试

2014年9月以来,报考我校学院路校区 HSK 考点的人数一直不断增多,从最初的每次4人一直增加到12月份的每次30多人,我校考生通过率约为98%,不仅为本校留学生和其他高校的留学生参加考试提供了便利条件,也为我校汉语国际教育工作产生了积极良好的影响。图1为HSK 考试现场,我校有良好的考试设备,及优良的服务,因此,越来越多的汉语生前来参加考试。

# Chinese Society and Culture course

The Chinese Society and Culture class helps students to familiarize themselves with elements of Chinese culture and to better understand the Chinese legal system in its creation, transplanting, evolution, and its interpretation and implementation. The main aim of this course is to shed light on the Chinese legal system by exploring the relationships between Chinese culture, society and law. The Chinese legal system is a crucial part of Chinese society. Furthermore, it is difficult for students to understand the Chinese legal system without studying the social background in China. Therefore, the course teaches students about the social background in China, including the Chinese economic system, political system, educational system, land system, Chinese population, culture, custom, history and religion. These subjects will help students to get a general understanding of the Chinese legal system. The class contains two parts: lectures and activities. By participating in the latter part, students will get to know more about Chinese culture and society by experiencing Chinese calligraphy and other forms of Chinese traditional art.
