


2015年春季学期小语种班再次火热开班!

巴西秘鲁国际教育展

2015年3月,中国政法大学随北京市教委 赴巴西、秘鲁参加了国际教育展及北京教育说 明会。本次外事公务主题鲜明,主要是在巴西 圣保罗举行北京教育展和在秘鲁利马举行北京 教育说明会;活动形式多样,除了国际教育展 和教育说明会, 还拜访了秘鲁国家议会教育委 员会、走访了圣保罗、里约热内卢、利马三个 城市的多所大学。在本次的国际教育展及北京 教育说明会上,很多学生对来中国留学有很大 的兴趣,中国政法大学受到了学习法律的学 生、律师、公务员的关注,他们积极地进行咨 询,了解法大的课程、住宿等相关情况,在此 期间我校发放了400份宣传材料,并记录了对 来中国政法大学学习感兴趣的咨询人员的联系 方式, 学校对外招生政策和教育教学成绩都有 很好的境外宣传效果。期间,还与秘鲁圣马丁 大学草签了合作的意向书。还与有一些学校达 成了派法律学习短期班的初步意向。

Summary of Law Courses for 2015 Spring semester

In the spring semester 2015, 10 law courses taught in English are offered by the School of International Studies to the international students, especially LL.M students and exchange students, including Criminal Justice in China, Chinese Labor Law, Chinese Legal System, Foreign Investment Law in China, Company Law, Chinese Securities Law, Private International Law, Introduction to Chinese Legal system, Environmental Law, Intellectual Property Law. Through these courses, the international students will gain both general picture and details of Chinese law as well as international law.

As many exchange student are interested in business law, CUPL also designs "Chinese Securities Law". The Chinese securities market is also well-developed in terms of its products and ways to raise capital. The leading banks are all listed companies, and securitization has connected many financial sectors. It follows that the securities law is a key component of financial laws and regulations. The course aims to introduce the regulatory regime of the securities law, and how the laws and regulations are applied by Chinese the courts and regulators.






For this purpose, there will be discussion of the basic concepts of the securities law and unique Chinese legal and cultural backgrounds. Laws and regulations, judicial interpretations and court cases will be discussed. Where appropriate, a comparative law approach will be used to illustrate important points.

Besides, the course "Foreign Investment Law in China" provides general knowledge of foreign investment law in China, including its concept, characteristics, historical development and classic theories. It also explains the background for evolution and jurisprudence to attract foreign investment. At the end of the course the students will be able to understand the applicable laws substantially for the foreign investment from different hierarchies of domestic laws in the People's Republic of China and Make independent research and critical thinking skills on the foreign investment law and possess necessary skills in preparing opinions, providing advice or recommending action in respect of issues of foreign investment law. In addition to the above courses, the Faculty of International Law provides International law courses every semester, which respectively focus on International Private Law, International Public Law, Environmental Law, Intellectual Property Law, Human Rights Law, Legal Research and Writing , Arbitration Law as well as Air and Space Law.

What's more, the course "Legal Research and Writing" teaches students more specific skills. The professor gives an overview about the possible sources of law to encourage students to make use of the sources both in Chinese and international law. During the courses, students will also learn how to read and interpret court decisions and

apply the WWW as a source of law. Finally the course focus on teaching students how to write an legal essay.

In this semester, 6 optional courses can be selected, including Chinese Society and Culture, Buddhism in China, Chinese Drama Stories, Chinese Tea Culture, Multicultural Psychology as well as China's Contemporary Politics and Society.

中国政法大学国际教育学院开设不同类型和层次的汉语进修课程,为具有不同汉语水平和多样化学习兴趣的外国留学生以及在华外籍人士提供优质的教学服务。我院在籍语言生共有83人,生源国有意大利、德国、俄罗斯、法国、菲律宾、巴基斯坦、韩国、几内亚、加纳等28个国家。

根据学生汉语水平分为入门班,基础班,初级班和中级班,学生可根据自己的汉语水平进行选择。入门班主要针对零基础的学生们,从拼音比划开始扎实的学习中文。基础班和初级班主要针对有一些汉语基础的留学生们,在专业的对外汉语老师的辅导下,尽快提高中文的听说读写能力。中级班主要针对中文程度较好,有意向用中文学习其他专业学历的留学生们。

本学期开设汉语听力, 汉语口语, 汉语综合,汉语语法,中国文化,法律汉语,中国太极文化,中国书法等课程。

HSK 考试

Chinese Society and Culture course

The class Chinese Society and Culture enable students to be intimate with 'Chinese elements' and better understand Chinese legal system in its making, transplanting, transformative updating, and its interpretation and implementation. The main focus of this course is to learn the Chinese legal system through exploring the correlation between the Chinese culture and society and law. Chinese legal system is a crucial part of Chinese society. It is difficult for students to get profound understanding of Chinese legal system without studying social background of China. Hence the course will teach the students the Chinese social background including Chinese economic system, political system, educational system, land system, Chinese population, culture, custom, history and religion. These subjects are strong support to get a general understanding of the Chinese legal system. Besides, the class contains two parts: lectures and experiencing activities. From the second part, students will get to know more about Chinese culture and society via experiencing Chinese calligraphy and other form of Chinese traditional art.
